PART II – PARENTAL PERMISSION

Participation in interscholastic athletics and intra-scholastic sports clubs includes a risk of injury which may range in severity from minor to long term catastrophic, including permanent paralysis or death. Although serious injuries are not common in supervised athletic programs or athletic clubs, it is possible only to minimize, not eliminate this risk. Participants have the responsibility to help reduce the chance of injury. Participants must obey all safety rules, report all physical problems to their coaches or club supervisors, follow a proper conditioning program and inspect their equipment daily.

- I give the Christian School Athletic Association or its representative(s) permission to review my child's scholastic records and all required eligibility forms however submitted by the school or myself.
- I understand that transportation may or may not be provided by CarenCro Catholic. (In the event transportation is not provided by the CarenCro, transportation will be the student's responsibility.) I release and waive, and further agree to indemnify, hold harmless or reimburse the CarenCro Catholic, its successors and assigns, its members, agents, employees and representatives thereof, as well as trip supervisors, from and against any claim which I, any other parent or guardian, any sibling, the student, or any other person, firm or corporation may have or claim to have, known or unknown, directly or indirectly, from any losses, damages or injuries arising out of, during, or in connection with the student's participation in the activity, any trip associated with the activity, or the rendering of emergency medical procedures or treatment if any.
- \$100.00 Athletic fee per school year. This will cover as many sports as they wish to participate in for the school year.
- If a student makes an "F" in any subject on the report card or a "D" in conduct, he/she will be dismissed from the current team or may not participate in any athletic activity during the following nine-week period.
- In the event an undesired behavior of an athlete warrants the discipline committee to issue a probationary period, then he/she will not be able to practice or play in the existing sport for a specified length of time.
- Any player, fan or coach that is ejected from a sporting event will not be allowed to participate or be in attendance at the next scheduled event. Any fan or coach that is removed from an event twice will be banned from attending any games for the remainder of the school year.
- Players must be enrolled in a league member school. League schools may combine rosters to form a team.
- Player Eligibility:
An 8th grade player cannot turn 15 years old before September 1st of the current school year.
A 7th grade player cannot turn 14 years old before September 1st of the current school year.

A 6th grade player cannot turn 13 years old before September 1st of the current school year.
A 5th grade player cannot turn 12 years old before September 1st of the current school year.
